Through this service contract we will cover all parts and labor as described below for one full year. We will also provide 24 hour emergency burner service under this contract. **Please note:** Hot water is not an emergency and will be scheduled during business hours: Weekdays 8am-5pm, Saturdays 8am-12pm. The annual cleaning is covered and will be scheduled during the non-heating season unless otherwise needed.
